Washington, May 18.—Eight members of the National Association of Home Builders will tour Poland in June to study housing construction, design and conditions.

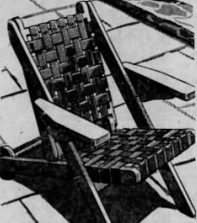
Heather Glen Soon to Show 'The Essex'
